Policies Please Initial

1. _____ The instructor has the final say as to what class(es) your child is placed in
2. _____ Tippy Toes Dance Studio does not carry medical insurance for it's students. It is required that all dancers be covered by their own family insurance and if injury occurs, it is understood that the student's policy is the only source of reimbursement.
3. _____ Leotards, tights and appropriate dance shoes are required for all calsses. This included no panties under your tights and leotard. Proper shoes in specific colors are required. Please label all shoes with your child's name and do NOT wear them outside of the studio at any time.
4. _____ ******BLACK LEOTARD AND PINK TIGHTS ARE REQUIRED FOR LEVEL 1-4 BALLET CLASSES.*****
5. _____ Please help class to run smoothly by going to the restroom before and after class. Class time is for learning not visting the restroom.
6. _____ NO gum, food, drinks, or cell phones allowed in the studio by parents, dancers, siblings or friends.

7. _____ The only visible piercing allowed on our dancers is the ear lobes of girls. If there are any other piercings, please have them removed prior to entering the studio. Absolutely no tattoos are allowed --NO exceptions.
8. _____ Students should not not be dropped off earlier than **15 minutes** prior to class or stay longer than **10 minutes afterwards**. They should remain inside until their ride arrives.
9. _____ Considering the precautions during Covid-19 if your child's class is in the big room please walk them the door on Edwards Street to enter class. If you child's class is in the little room please walk your child to the entrance on Pine Street. A teacher or assistant will escort your child to class from the Pine Street entrance. All students must wash/sanitize their hands upon entering.
10. _____ Disruptive behavior will not be tolerated. If this occurs repeatedly, parents will be contacted and if it continues, your child will be sent out of class.
11. _____ Please check your email weekly as that is the best way to communicate at this time until the lobby is opened back up to the general public.
12. _____ Tuition is due no later than the first day of summer classes. There are no discounts for the summer tuition it is all pro-rated for the 6 week course or stated the price for the clinics, mom's morning out, or audition weeks.
13. _____ There are no refunds for missed classes. These can be made up in an age appropriate class, even if it's a different style than what the student is taking.
14. _____ Classes are closed session. Please do not open the door during class time. When classes are over, the instructor will open the door.

Liability Release Form:

I understand that there are risks of physical injury associated with, arising out of, and inherent to the activity of dance. In recognition of the acknowledgement risk of injury, I knowingly and voluntarily waive all rights and/or causes of action of any kind, including all claims of negligence arising as a result of such activity from which liability could accrue to Tippy Toes Dance Studio, Inc, its' members, officers, agents, employees, instructors, assistants, subsidiaries and all affiliated entities (hereinafter collectively referred to as Tippy Toes Dance Studio).

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.
